



## TECHNICIAN CERTIFICATION PROGRAM APPLICATION FOR ENROLLMENT

The Frymaster Technician Certification Program is open to service technicians employed by Frymaster Authorized Servicers (FAS) and their sub-agents. To be **considered** for participation, technicians must be nominated by their Service Manager or the General Manager of the local FAS. The certification classes are limited to 16 students. Each student will be interviewed by Frymaster prior to acceptance. For this reason, applications must be received 45 days prior to class date and applicants will be notified of acceptance within 30 days prior to class date. **COST:** Attendees are responsible for travel to and from Shreveport, LA and hotel fees. Vans will be provided for transportation during the course of the school and will depart and return each day to the designated hotel, which will provide free breakfast. Frymaster will provide lunch each day. Attendees are responsible for evening meals. Please fill in all information on these forms.
